



Closing the gap:

Strengthening gender equality and protection from SGBV in disasters through law and policy

It is widely acknowledged that disasters affect women, men, boys, and girls in different ways. Socio-economic conditions, traditional practices, and cultural beliefs, often mean that women and their children are disproportionately affected; facing increased risk of death, injury, loss of livelihoods and sexual and gender-based violence (SGBV). In many contexts, gender inequality and discrimination limit women and girls' access to resources and influence over decisions governing their lives. Attention to gender issues and SGBV in disaster risk management are therefore critical to building disaster resilience and creating safer and more inclusive environments.

Engaging decision-makers and operational actors on this topic is essential to ensuring that national legal frameworks are developed and effectively implemented to tackle the specific challenges that women and girls face in disasters. Research carried out by the International Federation of Red Cross and Red Crescent Societies (IFRC) shows that laws can play a significant role in addressing gender inequality and SGBV in disasters. Yet, while many

countries have national legislation related both to gender and to disasters, and a few refer to gender in their national disaster policies, none of their disaster plans include arrangements for preventing and dealing with issues like SGBV. This further contributes to the generally low levels of awareness of SGVB in disasters.

In 2015, state parties to the International Conference of the Red Cross and Red Crescent adopted Resolution 3 on 'Sexual and gender-based violence: Joint action on prevention and response' (32IC/15/3). In addition, EU Member States signed a joint pledge at the conference to address SGBV in disasters.

To better understand the difficulties that women and girls face in disasters, with a focus on SGBV prevention and response, the IFRC launched a new research project in 2016 which specifically considers the role law and policy can play in addressing this issue. This research has included a global desk review and country case studies in Zimbabwe, Ecuador, and Nepal to assess the effectiveness of the relevant national legal frameworks.

The event will provide a forum to share the outcomes of this research and discuss how to strengthen law and policy to address gender inequality and SGBV in disasters. Gathering key stakeholders from the EU institutions, the humanitarian and developments sectors, and civil society, it seeks to raise awareness and ultimately contribute to producing better outcomes for women, children, and affected communities.
